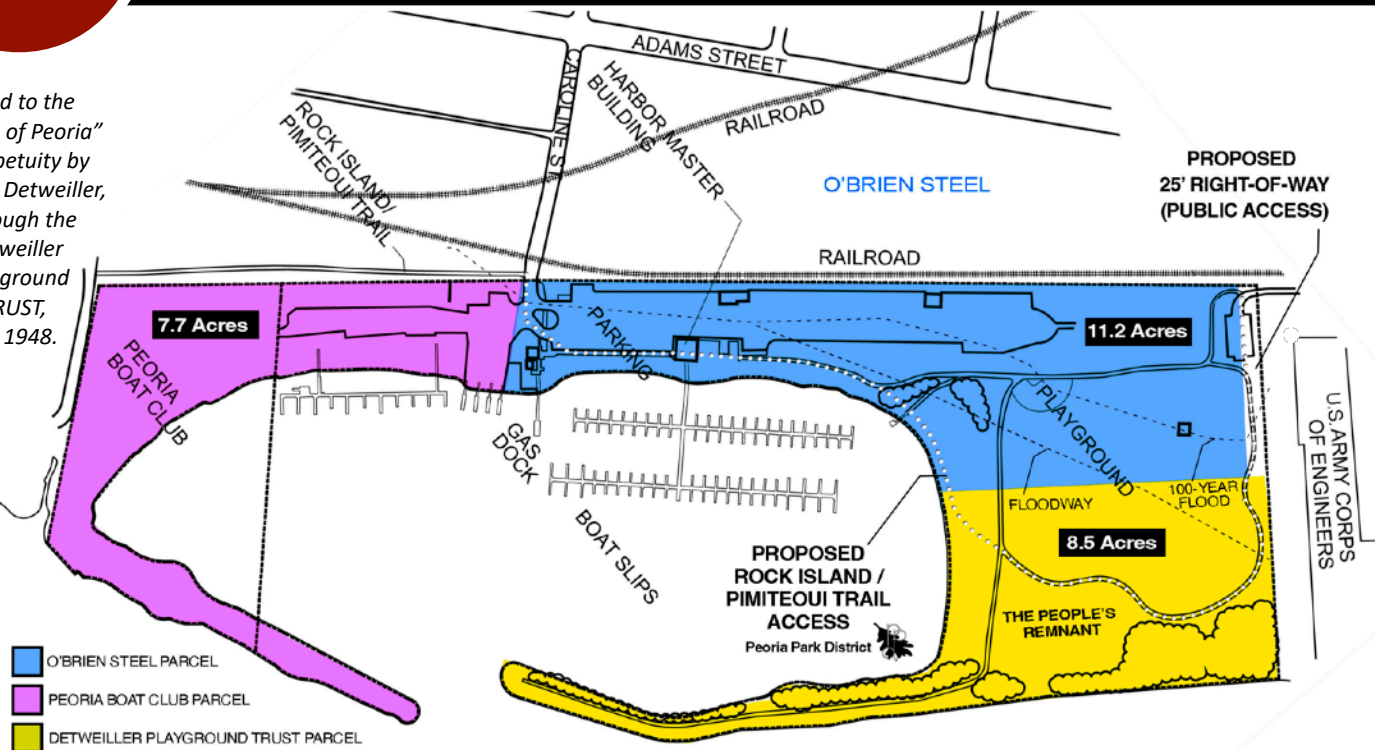

TRUST PROPERTY LAND SALE

The Detweiller Playground (& Marina) Trust — NOT the City of Peoria — is currently pursuing the sale of "Trust property" to entities including: "O'Brien Steel" and "Peoria Boat Club".

LOSS OF RIVERFRONT ACCESS

These actions may also lead to: restrictions or "loss of public access", including potential impacts to: Caroline Street — Bond Street — Direct neighborhood access to the riverfront

THIS IS A PIVOTAL MOMENT

Once public access is removed it is incredibly difficult if not impossible to restore.

Your involvement matters. Your voice matters. Together, we can work to protect this unique and irreplaceable part of our community.

CALL TO ACTION

IT'S IMPORTANT TO BE CLEAR

The CITY of PEORIA is NOT selling this land. The City's primary authority is over whether public streets (like Caroline and Bond) can be vacated (i.e. permanently closed).

MESSAGE

Please respectfully express your opposition to: Restricting public access and Deviating from the “original intent” of the Trust to have the land, “made available for playground and recreation purposes for the Peoria community.”

Encourage collaboration with the City of Peoria, Peoria Park District, other public charitable groups, and the public to:

- Explore options that **preserve** public ownership and/or access
- Keep the land **dedicated** to **community use** and **recreation** — Be **financially** sustainable.

CALL SCRIPT FOR YOUR PHONE CALLS

Be Respectful, Simple, and Effective

when calling Trustees, Park District, or City Officials:

“Hello, my name is [Your Name], and I live in [Neighborhood/Peoria area]. I’m calling about the Detweiller Playground Trust’s Land & Marina and the potential loss of public access to the river, including Caroline Street and Bond Street. I want to express my strong concern about any actions that would restrict public access or move away from the original intent of keeping this land open for recreation and community use. I am asking you to: Preserve public access to the river; Keep Caroline Street and Bond Street open; and Work toward a solution that keeps this land available for the public. This space is incredibly important to our community and I hope you will act to protect it.
